96.3 WDVD'S "Novi Home Show Electrolux Washer Giveaway" Contest Official Rules

The Station will conduct the **96.3 WDVD's "Novi Home Show Electrolux Washer Giveaway"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 or a prize valued at \$500 or more in the last six months, and whose immediate family members or household members have not won a prize from the Station in the last 30 or a prize valued at \$500 or more in the last six months Void where prohibited by law. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. Contest Period. The Contest entry period will begin at 6:00 am ET on January 6, 2025 and will run weekdays from 6:00 am ET until 10:00 am ET and from 3:00 pm ET until 7:00 pm ET the week of January 13 through 7:00 pm ET on January 17, 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter and Win.** Listen to the Station weekdays at or around **8:00 am ET, and 4:00 pm ET** during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners must call the Station at 866-298-9630. Caller 10 to the Station, as determined by the Station in its sole discretion, will win a qualifying prize (see Section 7 below) and be entered for a chance to win the grand prize. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- 4. **Grand Prize Winner Selection.** On or about 6:00pm ET on January 17, 2025, Station will select one potential winner in a random drawing from among all valid entries received by Station during the Contest Period. One winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

- 5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. - 7. Entry Conditions and Release.
